

# ANGOLA CUSTOMS ADMINISTRATION:

## A Leader in Combating Counterfeit and Transnational Crime



## SUCCESSES IN GLOBAL TRADE

The Angola Customs Administration (ACA) is the primary agency responsible for enforcing customs and trade laws in Angola.
