

ADMINISTRACIÓN FEDERAL DE INGRESOS PÚBLICOS (AFIP) - DIRECCIÓN GENERAL DE ADUANAS (DGA):

A Leader in Combating Counterfeit and Transnational Crime



The Argentina Administración Federal de Ingresos Públicos (AFIP) - Dirección General de Aduanas (DGA) has been at the forefront of combating counterfeit and transnational crime in Argentina. As the primary agency responsible for enforcing customs and excise laws, AFIP-DGA has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

AFIP-DGA has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (AFIP-DGA, 2022). Additionally, AFIP-DGA has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (AFIP-DGA, 2023).

For example, AFIP-DGA has signed a memorandum of understanding with the Brazilian Federal Revenue Service to share intelligence and coordinate efforts to combat cross-border crime (Brazilian Federal Revenue Service, 2023).

In 2023, AFIP-DGA participated in a regional workshop on combating counterfeit goods, organized by the WCO (WCO, 2023). The workshop brought together customs officials from several countries in the region to share best practices and discuss strategies for combating counterfeiting.

Recent Legal Reforms

In 2022, Argentina enacted the Customs Code, which strengthened the powers of AFIP-DGA to combat counterfeit and transnational crime (Government of Argentina, 2022). The Code introduced stricter penalties for customs offenses and provided for the use of advanced technology to detect and prevent smuggling.

The Code also introduced a new provision that allows AFIP-DGA to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Government of Argentina, 2022). This provision has enabled AFIP-DGA to work more closely with other agencies, such as the Argentine Federal Police, to combat crime.

Sustainable Development Initiatives

AFIP-DGA has also implemented sustainable development initia-

Combating Counterfeit Goods

Public Awareness

AFIP-DGA has also launched public awareness campaigns to educate the public on the dangers of counterfeit goods and the importance of complying with customs regulations (AFIP-DGA, 2022). In 2023, AFIP-DGA launched a campaign to educate the public on the risks of buying counterfeit goods, including the potential health and safety risks (AFIP-DGA, 2023). The campaign included radio and television advertisements, as well as social media posts, to reach a wider audience.

Stakeholder Engagement
