

# AUSTRALIAN CUSTOMS:

## A Leader in Combating Counterfeit and Transnational Crime



**SUCCESSES IN  
GLOBAL TRADE**

**The Australian Border Force (ABF) is the primary agency responsible for enforcing customs and trade laws in Australia. ABF has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.**

### Transparency Initiatives

ABF has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (ABF, 2022). ### Sustainable Development Initiatives
