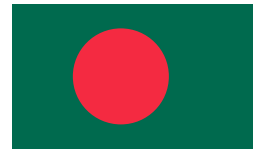


# NATIONAL BOARD OF REVENUE (NBR) CUSTOMS WING:

A Leader in Combating Counterfeit and Transnational Crime



**SUCCESSES IN  
GLOBAL TRADE**

The National Board of Revenue (NBR) Customs Wing has been at the forefront of combating counterfeit and transnational crime in Bangladesh. As the primary agency responsible for enforcing customs and excise laws, NBR Customs Wing has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

## Transparency Initiatives

NBR Customs Wing has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (NBR, 2022). Additionally, NBR Customs Wing has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (NBR, 2023).

In 2022, NBR Customs Wing launched a public awareness campaign to educate the public on the dangers of counterfeit goods and the importance of complying with customs regulations (NBR, 2022). ## Recent Legal Reforms

The Act also introduced a new provision that allows NBR Customs Wing to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Government of Bangladesh, 2022). This provision has enabled NBR Customs Wing to work more closely with other agencies, such as the Bangladesh Police, to combat crime.

## Sustainable Development Initiatives
