

# **BOLIVIA CUSTOMS:**

# A Leader in Combating Counterfeit and Transnational Crime



Bolivia Customs has been at the forefront of combating counterfeit and transnational crime in Bolivia. As the primary agency responsible for enforcing customs and trade laws, Bolivia Customs has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.
