

CENTRAL AFRICAN REPUBLIC CUSTOMS ADMINISTRATION:

Challenges and Opportunities



The Central African Republic Customs Administration (CARCA) is the primary agency responsible for enforcing customs and trade laws in the Central African Republic (CAR). Despite facing significant challenges, CARCA has made efforts to improve its operations and combat counterfeit and transnational crime.

Challenges

According to the WCO, CARCA has also participated in several international training programs, including a training program on customs enforcement organized by the WCO (WCO, 2022).

Public Awareness

CARCA has also implemented several public awareness initiatives to educate the public on the dangers of counterfeit goods and the importance of complying with customs regulations. One such initiative is the publication of public awareness materials, including brochures and posters (CARCA, 2023).
