

SERVICIO NACIONAL DE ADUANAS (SNA) DE CHILE:

A Leader in Combating Counterfeit and Transnational Crime



The Servicio Nacional de Aduanas (SNA) de Chile has been at the forefront of combating counterfeit and transnational crime in Chile. As the primary agency responsible for enforcing customs and excise laws, SNA has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

SNA has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (SNA, 2022). Additionally, SNA has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (SNA, 2023).

Recent Legal Reforms

The Code also introduced a new provision that allows SNA to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Government of Chile, 2022). This provision has enabled SNA to work more closely with other agencies, such as the Chilean Federal Police, to combat crime.

Sustainable Development Initiatives

SNA has also implemented sustainable development initiatives to reduce its environmental footprint. Public Awareness
