

EL SALVADOR CUSTOMS:

A Leader in Combating Counterfeit and Transnational Crime



SUCCESSES IN GLOBAL TRADE

El Salvador Customs has been at the forefront of combating counterfeit and transnational crime in El Salvador. As the primary agency responsible for enforcing customs and trade laws, El Salvador Customs has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

El Salvador Customs has implemented several transparency initiatives to promote accountability and trust among stakeholders.
