

# ETHIOPIAN CUSTOMS COMMISSION (ECC):

A Leader in Combating Counterfeit and Transnational Crime

The Ethiopian Customs Commission (ECC) has been at the forefront of combating counterfeit and transnational crime in Ethiopia. As the primary agency responsible for enforcing customs and excise laws, ECC has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

# **Transparency Initiatives**

ECC has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (ECC, 2022). The Proclamation also introduced a new provision that allows ECC to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Government of Ethiopia, 2022). This provision has enabled ECC to work more closely with other agencies, such as the Ethiopian Federal Police, to combat crime.

# **Sustainable Development Initiatives**

ECC has also implemented sustainable development initiatives to reduce its environmental footprint. The agency has introduced a paperless clearance system, which has reduced the use of paper and minimized waste (ECC, 2023).
