

# KENYA CUSTOMS:

## A Leader in Combating Counterfeit and Transnational Crime



**SUCCESSES IN  
GLOBAL TRADE**

**The Kenya Revenue Authority (KRA) is the primary agency responsible for enforcing customs and trade laws in Kenya. KRA has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.**

### Transparency Initiatives

KRA has implemented several transparency initiatives to promote accountability and trust among stakeholders.
