

CUSTOMS DEPARTMENT OF THE REPUBLIC OF LITHUANIA:

A Leader in Combating Counterfeit and Transnational Crime

SUCCESSES IN GLOBAL TRADE

The Customs Department of the Republic of Lithuania (CDRL) is the primary agency responsible for enforcing customs and trade laws in Lithuania. In recent years, the CDRL has made significant strides in combating counterfeit and transnational crime, and has implemented various initiatives to promote transparency, international cooperation, and sustainable development.

Transparency Initiatives
