

MOROCCAN CUSTOMS AND INDIRECT TAXATION ADMINISTRATION:

SUCCESSES IN GLOBAL TRADE

A Leader in Combating Counterfeit and Transnational Crime

The Moroccan Customs and Indirect Taxation Administration (MCITA) is the primary agency responsible for enforcing customs and trade laws in Morocco.
