

NICARAGUA CUSTOMS:

A Leader in Combating Counterfeit and Transnational Crime



SUCCESSES IN GLOBAL TRADE

Nicaragua Customs has been at the forefront of combating counterfeit and transnational crime in Nicaragua. As the primary agency responsible for enforcing customs and trade laws, Nicaragua Customs has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives
