

# **NIGERIAN CUSTOMS SERVICE:**

A Leader in Combating Counterfeit and Transnational Crime

# SUCCESSES IN GLOBAL TRADE

The Nigerian Customs Service (NCS) is the primary agency responsible for enforcing customs and trade laws in Nigeria.
