

# DIRECCIÓN NACIONAL DE ADUANAS (DNA):

A Leader in Combating Counterfeit and Transnational Crime



# SUCCESSES IN GLOBAL TRADE

The Dirección Nacional de Aduanas (DNA) has been at the forefront of combating counterfeit and transnational crime in Paraguay. As the primary agency responsible for enforcing customs and tax laws, DNA has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

## **Transparency Initiatives**

DNA has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (DNA, 2022). Additionally, DNA has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (DNA, 2023).

In 2022, DNA launched a public awareness campaign to educate the public on the dangers of counterfeit goods and the importance of complying with customs regulations (DNA, 2022). The campaign included radio and television advertisements, as well as social media posts, to reach a wider audience.

This provision has enabled DNA to work more closely with other agencies, such as the Policía Nacional del Paraguay, to combat crime.

## **Sustainable Development Initiatives**

# **Capacity Building**

The agency has provided training to its officers on customs enforcement, risk management, and investigative techniques (DNA, 2023). Additionally, DNA has partnered with international organizations, such as the WCO, to provide technical assistance and capacity building programs (WCO, 2022).

#### **Public Awareness**
