

# SUPERINTENDENCIA NACIONAL DE ADUANAS Y DE ADMINISTRACIÓN **TRIBUTARIA (SUNAT):** A Leader in Combating Counterfeit and Transnational Crime

SUCCESSES IN GLOBAL TRADE

The Superintendencia Nacional de Aduanas y de Administración Tributaria (SUNAT) has been at the forefront of combating counterfeit and transnational crime in Peru. As the primary agency responsible for enforcing customs and tax laws, SUNAT has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

# Transparency Initiatives

SUNAT has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (SUNAT, 2022). Additionally, SUNAT has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (SUNAT, 2023).

# **Recent Legal Reforms**

The Law also introduced a new provision that allows SUNAT to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Government of Peru, 2022). This provision has enabled SUNAT to work more closely with other agencies, such as the Policía Nacional del Perú, to combat crime.

## Sustainable Development Initiatives

The system uses blockchain technology to create a secure and transparent record of the movement of goods, which can help to prevent counterfeiting and smuggling.

# **Combating Counterfeit Goods**

SUNAT has also intensified its efforts to combat counterfeit goods. The agency has established a dedicated unit to investigate and prosecute cases of counterfeiting (SUNAT, 2022). In 2023, SUNAT seized over 2,000 counterfeit goods, including clothing, electronics, and cosmetics, worth over PEN 1 million (SUNAT, 2023).

In 2022, SUNAT and the Policía Nacional del Perú conducted a joint operation to seize counterfeit goods, which resulted in the seizure of over 1,000 counterfeit goods worth over PEN 500,000 (SUNAT, 2022).

# **Capacity Building**

SUNAT has also invested in capacity building to enhance its ability to combat counterfeit and transnational crime. The agency has provided training to its officers on customs enforcement, risk management, and investigative techniques (SUNAT, 2023). Additionally, SUNAT has partnered with international organizations, such as the WCO, to provide technical assistance and capacity building programs (WCO, 2022).
