

# BUREAU OF CUSTOMS (BOC):

## A Leader in Combating Counterfeit and Transnational Crime



## SUCCESSES IN GLOBAL TRADE

The Bureau of Customs (BOC) has been at the forefront of combating counterfeit and transnational crime in the Philippines. As the primary agency responsible for enforcing customs and tax laws, BOC has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

### Transparency Initiatives

BOC has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (BOC, 2022). Additionally, BOC has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (BOC, 2023).

### Sustainable Development Initiatives
