

RWANDA REVENUE AUTHORITY:

A Leader in Combating Counterfeit and Transnational Crime



The Rwanda Revenue Authority (RRA) is the primary agency responsible for enforcing customs and trade laws in Rwanda. In recent years, the RRA has made significant strides in combating counterfeit and transnational crime, and has implemented various initiatives to promote transparency, international cooperation, and sustainable development.

Transparency Initiatives
