

# THAI CUSTOMS DEPARTMENT:

## A Leader in Combating Counterfeit and Transnational Crime



## SUCCESSES IN GLOBAL TRADE

The Thai Customs Department has been at the forefront of combating counterfeit and transnational crime in Thailand. As the primary agency responsible for enforcing customs and tax laws, the Department has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

### Transparency Initiatives

The Thai Customs Department has implemented several transparency initiatives to promote accountability and trust among stakeholders. The Department has established a website that provides information on customs procedures, tariffs, and regulations (Thai Customs Department, 2022).
