

TURKISH CUSTOMS AND TRADE MINISTRY:

A Leader in Combating Counterfeit and Transnational Crime



SUCCESSES IN GLOBAL TRADE

The Turkish Customs and Trade Ministry has been at the forefront of combating counterfeit and transnational crime in Turkey. As the primary agency responsible for enforcing customs and trade laws, the Ministry has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

The Turkish Customs and Trade Ministry has implemented several transparency initiatives to promote accountability and trust among stakeholders. The Ministry has established a website that provides information on customs procedures, tariffs, and regulations (Turkish Customs and Trade Ministry, 2022).
