

# UNITED STATES CUSTOMS AND BORDER PROTECTION:

A Leader in Combating Counterfeit and Transnational Crime



# SUCCESSES IN GLOBAL TRADE

U.S. Customs and Border Protection (CBP) is the primary agency responsible for enforcing customs and trade laws in the United States. CBP has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

# **Transparency Initiatives**

CBP has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (CBP, 2022). Additionally, CBP has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (CBP, 2023).

## **Recent Legal Reforms**

#### **Public Awareness**
