

## **UGANDA CUSTOMS:**

# A Leader in Combating Counterfeit and Transnational Crime



The Uganda Revenue Authority (URA) is the primary agency responsible for enforcing customs and trade laws in Uganda. URA has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

#### **Transparency Initiatives**

URA has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (URA, 2022).
