

URUGUAY CUSTOMS:

A Leader in Combating Counterfeit and Transnational Crime



The National Customs Directorate of Uruguay (DNA) is the primary agency responsible for enforcing customs and trade laws in Uruguay. DNA has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

DNA has implemented several transparency initiatives to promote accountability and trust among stakeholders.
