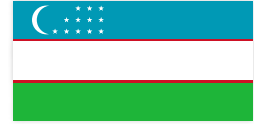


# UZBEKISTAN CUSTOMS:

## A Leader in Combating Counterfeit and Transnational Crime



## SUCCESSES IN GLOBAL TRADE

The State Customs Committee of Uzbekistan (SCC) is the primary agency responsible for enforcing customs and trade laws in Uzbekistan. SCC has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

### Transparency Initiatives

SCC has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (SCC, 2022). Additionally, SCC has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (SCC, 2023).

In 2022, SCC launched a public awareness campaign to educate the public on the dangers of counterfeit goods and the importance of complying with customs regulations (SCC, 2022). The campaign included radio and television advertisements, as well as social media posts, to reach a wider audience.

### Recent Legal Reforms

The Code also introduced a new provision that allows SCC to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Uzbekistan Government, 2022). This provision has enabled the agency to work more closely with other agencies, such as the Uzbekistan National Security Service, to combat crime.

### Sustainable Development Initiatives

SCC has also implemented sustainable development initiatives to reduce its environmental footprint. The agency has introduced a paperless clearance system, which has reduced the use of paper and minimized waste (SCC, 2023).
