

ZAMBIA REVENUE AUTHORITY -CUSTOMS SERVICES DIVISION:

A Leader in Combating Counterfeit and Transnational Crime



The Zambia Revenue Authority - Customs Services Division (ZRA-CSD) is the primary agency responsible for enforcing customs and trade laws in Zambia. In recent years, the ZRA-CSD has made significant strides in combating counterfeit and transnational crime, and has implemented various initiatives to promote transparency, international cooperation, and sustainable development.

Transparency Initiatives

The ZRA-CSD has implemented several transparency initiatives to promote accountability and trust among stakeholders.
