The Zimbabwe Revenue Authority - Customs and Excise Division (ZIMRA-CED) is the primary agency responsible for enforcing customs and trade laws in Zimbabwe. In recent years, the ZIMRA-CED has made significant strides in combating counterfeit and transnational crime, and has implemented various initiatives to promote transparency, international cooperation, and sustainable development.

Transparency Initiatives

The ZIMRA-CED has implemented several transparency initiatives to promote accountability and trust among stakeholders. One such initiative is the publication of the Zimbabwe Customs Tariff Handbook, which provides detailed information on customs procedures, tariffs, and regulations (ZIMRA-CED, 2022). Recent Legal Reforms
