

ALGERIA CUSTOMS:

A Leader in Combating Counterfeit and Transnational Crime



SUCCESSES IN GLOBAL TRADE

The Algerian Customs Authority (ACA) is the primary agency responsible for enforcing customs and trade laws in Algeria. ACA has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

ACA has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (ACA, 2022). Additionally, ACA has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (ACA, 2023).

Recent Legal Reforms

The Law introduced stricter penalties for customs offenses and provided for the use of advanced technology to detect and prevent smuggling.

The Law also introduced a new provision that allows ACA to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Algerian Government, 2022). This provision has enabled the agency to work more closely with other agencies, such as the Algerian National Police, to combat crime.

Sustainable Development Initiatives

ACA has also implemented sustainable development initiatives to reduce its environmental footprint. The agency has introduced a pa-

perless clearance system, which has reduced the use of paper and minimized waste (ACA, 2023). Additionally, ACA has implemented energy-efficient lighting and air conditioning systems at its facilities, which has reduced energy consumption and greenhouse gas emissions (ACA, 2024).

Public Awareness
