

ESTONIAN CUSTOMS AGENCY:

A Leader in Combating Counterfeit and Transnational Crime



SUCCESSES IN GLOBAL TRADE

The Estonian Customs Agency has been at the forefront of combating counterfeit and transnational crime in Estonia. As the primary agency responsible for enforcing customs and trade laws, the Estonian Customs Agency has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives
