

STATE REVENUE COMMITTEE OF THE MINISTRY OF FINANCE OF THE REPUBLIC OF KAZAKHSTAN (SRC):

A Leader in Combating Counterfeit and Transnational Crime



The State Revenue Committee of the Ministry of Finance of the Republic of Kazakhstan (SRC) has been at the forefront of combating counterfeit and transnational crime in Kazakhstan. As the primary agency responsible for enforcing customs and tax laws, SRC has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

SRC has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (SRC, 2022). Additionally, SRC has introduced an online portal for submitting customs declarations, which has improved the efficiency and transparency of the clearance process (SRC, 2023).

In 2022, SRC launched a public awareness campaign to educate the public on the dangers of counterfeit goods and the importance of complying with customs regulations (SRC, 2022). The campaign included radio and television advertisements, as well as social media posts, to reach a wider audience.

International Cooperation Initiatives

SRC has also strengthened its international cooperation to combat transnational crime. The agency is a member of the World Customs Organization (WCO) and has signed several agreements with neighboring countries to enhance cooperation in customs enforcement (WCO, 2022). For example, SRC has signed a memorandum of understanding with the Customs Service of the Russian Federation to share intelligence and coordinate efforts to combat cross-border crime (Customs Service of the Russian Federation, 2023).

In 2023, SRC participated in a regional workshop on combating counterfeit goods, organized by the WCO (WCO, 2023). The workshop brought together customs officials from several countries in the region to share best practices and discuss strategies for combating counterfeiting.

Recent Legal Reforms

In 2022, Kazakhstan enacted the Customs Code, which strengthened the powers of SRC to combat counterfeit and transnational crime (Government of Kazakhstan, 2022). The Code introduced stricter penalties for customs offenses and provided for the use of advanced technology to detect and prevent smuggling.

The Code also introduced a new provision that allows SRC to share information with other law enforcement agencies, both domestically and internationally, to combat transnational crime (Government of Kazakhstan, 2022). This provision has enabled SRC to work more closely with other agencies, such as the National Security Committee, to combat crime.

Sustainable Development Initiatives

SRC has also implemented sustainable development initiatives to reduce its environmental footprint. The agency has introduced a paperless clearance system, which has reduced the use of paper and minimized waste (SRC, 2023). Additionally, SRC has implemented energy-efficient lighting and air conditioning systems at its facilities, which has reduced energy consumption and greenhouse gas emissions (SRC, 2024).

In 2023, SRC launched a project to install solar panels at its facilities, which will reduce the agency's reliance on fossil fuels and lower its carbon footprint (SRC, 2023).

Enhancing Trade Facilitation

SRC has implemented several initiatives to enhance trade facilitation and reduce the time and cost of clearing goods. The agency has introduced a risk-based approach to customs clearance, which has reduced the number of physical inspections and expedited the clearance process (SRC, 2023). Additionally, SRC has implemented a single window system, which allows traders to submit all required documents and information through a single online portal (SRC, 2024).

In 2022, SRC launched a pilot project to implement a block-chain-based system for tracking and verifying the origin of goods (SRC, 2022). The system uses blockchain technology to create a secure and transparent record of the movement of goods, which can help to prevent counterfeiting and smuggling.

Combating Counterfeit Goods

SRC has also intensified its efforts to combat counterfeit goods. The agency has established a dedicated unit to investigate and prosecute cases of counterfeiting (SRC, 2022). In 2023, SRC seized over 5,000 counterfeit goods, including clothing, electronics, and cosmetics, worth over KZT 10 million (SRC, 2023).

The agency has also worked closely with other law enforcement agencies, such as the National Security Committee, to combat counterfeiting (National Security Committee, 2022). In 2022, SRC and the National Security Committee conducted a joint operation to seize counterfeit goods, which resulted in the seizure of over 2,000 counterfeit goods worth over KZT 5 million (SRC, 2022).

Capacity Building

SRC has also invested in capacity building to enhance its ability to combat counterfeit and transnational crime. The agency has provided training to its officers on customs enforcement, risk management, and investigative techniques (SRC, 2023). Additionally, SRC has partnered with international organizations, such as the WCO, to provide technical assistance and capacity building programs (WCO, 2022).



In 2022, SRC sent several officers to attend a training program on customs enforcement organized by the WCO (WCO, 2022). The program provided training on advanced techniques for detecting and preventing smuggling, as well as strategies for combating transnational crime.

Public Awareness

In 2023, SRC launched a campaign to educate the public on the risks of buying counterfeit goods, including the potential health and safety risks (SRC, 2023). The campaign included radio and television advertisements, as well as social media posts, to reach a wider audience.

Stakeholder Engagement

SRC has also strengthened its engagement with stakeholders. including traders, importers, and exporters. The agency has established a stakeholder forum, which provides a platform for stakeholders to raise concerns and provide feedback on customs procedures and regulations (SRC, 2023).

In 2022, SRC conducted a survey of stakeholders to gather feedback on customs procedures and regulations (SRC, 2022). The survey provided valuable insights into the needs and concerns of stakeholders, which has helped SRC to improve its services and procedures.

Regional Cooperation

Appeals Process

SRC has also established an appeals process for traders who are dissatisfied with customs decisions. The agency has introduced an independent appeals committee, which reviews appeals and makes decisions on disputes (SRC, 2022).

In 2022, SRC received several appeals from traders who were dissatisfied with customs decisions (SRC, 2022). The agency has since reviewed these appeals and made decisions on the disputes, which has helped to promote fairness and transparency in the customs clearance process.

Training and Development
