

MALTA CUSTOMS: A Leader in Combating Counterfeit and Transnational Crime



The Malta Customs Department (MCD) is the primary agency responsible for enforcing customs and trade laws in Malta. MCD has been at the forefront of combating counterfeit and transnational crime, and has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

MCD has implemented several transparency initiatives to promote accountability and trust among stakeholders. The agency has established a website that provides information on customs procedures, tariffs, and regulations (MCD, 2022).
