

NAMIBIA CUSTOMS AND EXCISE:

A Leader in Combating Counterfeit and Transnational Crime



**SUCCESSES IN
GLOBAL TRADE**

The Namibia Customs and Excise has been at the forefront of combating counterfeit and transnational crime in Namibia. As the primary agency responsible for enforcing customs and tax laws, Namibia Customs and Excise has implemented various initiatives to prevent the flow of counterfeit goods and to facilitate legitimate trade.

Transparency Initiatives

Namibia Customs and Excise has implemented several transparency initiatives to promote accountability and trust among stakeholders.
